LAY-BY AGREEMENT TERMS & CONDITIONS

Please read these terms and conditions carefully.

1. In these terms, "Clark Rubber is "We" or "Us" and the "Customer" is "You".
2. This is a Lay-by agreement.
3. You have agreed to purchase the Goods specified in Item 1 of the Details Schedule from Us by way of 2 or more instalment payments before the End Date specified in Item 4 of the Details Schedule.
4. The End Date will be no more than 60 days from the Lay-by Commencement Date specified in Item 3 of the Details Schedule.
5. The Total Purchase Price for the Goods is specified in Item 2 of the Details Schedule
6. At the Lay-by Commencement Date You agree to pay a minimum deposit of 15% of the Total Purchase Price and thereafter each instalment payment must be at a minimum 10% of the Total Purchase Price and paid on a fortnightly basis.
7. You will be required to present this Lay-by agreement at the time of making any instalment payments.
8. Full title and ownership in the Goods will pass to You on payment and receipt of the Total Purchase Price before or on the End Date.
9. You will not be permitted to collect the Goods until such time You have paid the Total Purchase Price.
10. You may terminate this Lay-by agreement at any time.
11. If You fail to pay the Total Purchase Price before the End Date and/or the Goods are not collected and We have given You 14 days written notice to pay the Total Purchase Price and/or collect the Goods, We may terminate the Lay-by Agreement.
12. Where a Lay-by agreement is terminated, We will refund to You all money paid less an amount equivalent to 10% of the Total Purchase Price as a termination charge.
13. You acknowledge the termination fee will be no more than Our reasonable costs in relation to the cancellation of the Lay-by agreement.
